Depreciation is the next area we will discuss. These are basically items that cost more than \$100 and are depreciated over a certain period of time. We should buy depreciable items each and every year. Not only will this keep us current with modern machinery, but it will also please our personal tastes with items that are fun to have. Items such as computer's, TV's, and VCR's - items which can be used in our business but may not be used 100% of the time.

# 6. The possibility of amortization -

This occurs when you buy an item, for example, a computer that was bought in March, 2014 but you didn't get into your business until July, 2014. Even though the computer was bought prior to your getting into business, it may now be written off. A portion of this machinery would be written off in the years to come. This is a financial advantage.

### 7. Office In The Home -

This is the deduction that gives us credit for running our business out of our home. Basically, it states that we're able to assign a value to the space we utilize for our business. We are able to deduct a percentage of mortgage interest, real estate taxes, insurance on the home, repairs and maintenance, and utilities. All of these factors together can amount to thousands of dollars and the costs were already there, whether you are in a business or not. This office in the home can be a great advantage, even though the rules for obtaining the office in the home deduction may be difficult for some to meet. Becoming successful in a business will enhance the expenses of having this deduction.

## 8. Non-economic -

Last but not least, the non-economic factor, such as the meeting of new people who could enhance not only your business life but maybe your personal life as well. Visiting different parts of the country, meeting and entertaining at sporting events, dining in fine restaurants, and staying at great hotels and motels.
